(b)(i) with 5 years service in the grade rendered after appointment thereto on a regular basis in posts in PB-3 (Rs. 15600-39100) with Grade Pay Rs. 5400 or equivalent in the parent cadre/department; and possessing the following educational qualifications and experience;

(ii) Master's degree of a recognized University or equivalent i.e. M.A., M.Sc., M.Com. and MBA, and

(iii) 5 years experience in Banking and/or Insurance/Market research and training. The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationist shall not be eligible for consideration for appointment by promotion

(Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other Organisation/Department of the Central Government shall ordinarily not exceed four years. The maximum age limit for appointment by deputation shall be not exceeding 56 years, as on the closing date of receipt of applications.

Note: For the purpose of appointment on deputation/absorption basis, the service rendered on regular basis by an officer prior to 1.1.2006(the date from which the revised pay structure based on the 6th CPC recommendation has been extended) shall be deemed to be service rendered in the corresponding Grade Pay/Pay Scale extended based on the recommendations of the Pay Commission except where there has been merger of more than one pre-revised scale of pay into one grade with a common Grade Pay/Pay Scale, and where this benefit will extend only for the post(s) for which that Grade Pay/Pay Scale is the normal replacement grade without any upgradation.
