NSI observes Pay Roll Savings Day throughout the Country

It has been endeavour of the NSO (now NSI) for the last five decades to provide saving instruments suitable to the needs of various strata of society. Pay Roll Savings Scheme is an exclusive scheme to meet the requirement of the salaried class across the country who want to have a regular saving every month. In this system of savings, the employee gives an authorisation to the employer to deduct a fixed amount from the salary for opening a Post Office Recurring Deposit Account, Public Provident Fund Account and to purchase NSC VIII issue from designated post office. This system makes savings automatic & regular for the employee and the employee does not have to go to the post office for making deposits. To boost up the Pay Roll Savings Scheme and give more thrust to personal savings, National Savings Institute every year observes 15th July as Pay Roll Savings Day. This year also the Pay Roll Savings Day was observed throughout the country at the headquarters of all Regional Directors on 15th July 2006. On this occasion, NSI appreciated the efforts made by Officers/Units/Establishments, who have done good work under Pay Roll Savings Scheme. A Special Ad. highlighting the importance of the Day was also published in the leading news papers of the country through DAVP, New Delhi.

Govt. of India Issues Clarification relating to TDS on SCSS

The Ministry of Finance (DEA's), Govt. of India has issued the clarification received from Central Board of Direct Taxes relating to tax deduction at source on payment of interest on deposits under Senior Citizen's Savings Scheme vide their letter No. F.2/8/2005 NS-II dated 23.6.2006.

It is clarified that -

- (i) An individual resident in India of 65 years of age or above may furnish a declaration in Form No. 15-H to the Bank/Post Office if the tax on the estimated income for the financial year is nil.
- (ii) A declaration in Form No. 15-G can be furnished by a depositor of less than 65 years of age, if
 - (a) the tax on the estimated total income for the financial year is nil, and
 - (b) the aggregate amount of interest credited or paid or likely to be credited or paid during the financial year is not more than the maximum amount which is not chargeable to tax (Rs. 1,00,000/- for male tax payers and Rs. 1,35,000/- for female tax payers.)

 Note: Both the above conditions are required to be fulfilled. The information relating to deposits under the Senior Citizens Savings Schemes, 2004 may be given by the depositors in Schedule III of Form No. 15-G.
- (iii) In suitable cases, a certificate for lower deduction or no deduction of tax at source under Section 197 (1) may also be obtained by the depositors from their assessing officers.
- (iv) On furnishing of a declaration in Form 15-H or Form 15-G to the Bank/Post Office, no deduction of tax shall be made by the Bank/Post Office as the case where a certificate under Section 197 (1) from the Assessee Officer is furnished to them, the Banks/Post Offices shall not deduct tax at source or, as the case may be, deduct at a lower rate as specified in the certificate.
- (v) In case of such tax as was not deducted by Banks/Post Offices for the financial years 2004-05 and 2005-06, it is clarified that such portion of the tax not so deducted by Banks/ Post Offices, which has been paid directly by the depositors as advance tax or selfassessment tax or otherwise and for which necessary evidence is furnished by the depositors to the Bank/Post Office, such tax will not be recovered by the Income Tax Department from the Banks/Post Offices, similarly, to the extent of the amount for which declarations in forms 15-H and 15-G as well as certificates under Section 197(1) are available with the Banks/Post Offices, the Income Tax Department would not make recovery from the Banks/Post Offices.
