## India Participates in the International Meeting on "Business Cooperation" at Bangkok, Thailand

The Ministry of Finance, Govt. of India nominated Shri Anil Bhattacharya, Head of Department, National Savings Institute, to participate in the meeting on 'Business Cooperation' organized by WSBI, for Asia Pacific Regional Group Members at Bangkok, during 26-27 January 2006. Shri C. Worthing, Under Secretary, Ministry of Finance, also participated.

The meeting was attended by number of countries from Asia Pacific Region i.e. India, Mongolia, Sri Lanka, Vietnam, Japan, Malaysia, Kazakisthan and Thailand. During the meeting various issues related to payment systems as well as remittances were discussed. The highlights of the discussion was how to chanalize the money, which is coming from the different countries through informal channels.

Shri Bhattacharya and Shri Worthing called on the His Excellency, the Indian Ambassador - Embassy of India Shri Vivek Katju and briefed him about the various activities of NSI in the field of mobilization of resources and International Cooperation. During the discussion the Indian Ambassador appreciated the efforts made by NSI in the field of international cooperation and also felt that there can be bilateral arrangement in the international cooperation between Thailand & India.

The meeting was attended by all the PMGs from Maharashtra, Shri Anil Bhattacharya, Jt. NSC & Head of Deptt., Shri Nassir Sajjad, RD, Mumbai, Jt. Director, Small Savings, Govt. of Maharashtra, Mumbai, Shri Q.D. Shah, Dy. Director and Shri A.D. Sawant, Dy. Director, NSI Mumbai also attended the meeting.

During the meeting, various issues were discussed, specially - How to make distribution channel more effective ? - How to prevent frauds committed by the agents, as well as the people who are working at the distribution channel since NSI products are marketed through Postal network as well as through Banks. To prevent the malpractices/fraud, it was also decided to conduct periodical training programmes for the agents, and postal staff working at the distribution channel and publishing Ad. in the print media about the 'Do's & Don'ts' for creating awareness among the investors by NSI. Shri Anil Bhattacharya Head of Deptt. NSI stressed the need for imparting training to the persons dealing with the customers, since customers are very important for mobilisation of resources.
