Hon'ble Union Finance Minister Launches Website of NSI

The Hon'ble Union Finance Minister, Shri P. Chidambaram launched the website of National Savings Institute at the special function organised in New Delhi on 30th May 2006. The objective of this website is to facilitate citizen's interface with the Government in the area of Small Savings on an e-Governance platform. The website is *http://nsiindia.gov.in*. This website is developed by NSI in collaboration with National Informatics Center. The basic objective of this website is dissemination of information and online redressal of complaints related to the various Small Savings Schemes offered by the Central Government. This website is a single window mechanism for on line redressal of grievances and providing information on products, agency and distribution channels. The website also offers down load facility for commonly used forms for depositors.

Shri Ashok Jha, IAS, Secretary Economic Affairs highlighted the achievements of NSI during 2005-06 and the salient features of the website. The function was also attended by Hon'ble Minister of State (Finance), Secretary (Finance), Secretary (Revenue), Secretary (Banking), Dy. Governor of Reserve Bank of India, Jt. Secretaries from the Ministry of Finance, CCA, Ministry of Finance, Director/Jt. Director & Regional Directors from NSI and the Senior Officers from the other departments including Director General of NIC.

At the end of the function, Smt. L.M. Vas, I.A.S., Jt. Secretary (Budget) Ministry of Finance, Department of Economic Affairs, met the media persons and replied all the queries raised by them.

Salient Features of NSI Website

The website of NSI, http://nsiindia.gov.in is a single window mechanism for online redressal of grievance/complaint or query on the NSI website and track its status using a unique auto generated code number. The NSI's Regional center concerned will ensure the redressal of grievance/complaint or answering the queries through suitable interface with state government, post office or bank as the case may be and respond through e-mail or post, as indicated by the user. On line complaints and queries received by NSI and its Regional Offices can be transferred to the online system for tracking and monitoring by the Ministry.

The website has two main components viz. Static and Dynamic. The static component covers various facts of NSI i.e. What is NSI mission and vision, Organizational chart, Addresses of Head Quarter and Regional Centers, History of savings in India, Progress of small savings, National Savings Products, Extension Agencies, Training and Development, Distribution of products International cooperation etc. The dynamic component covers the procedural aspects of use of online system, time taken for redressal process, generating various related reports (statewise/districtwise) and knowing the redressal status.

This website will provide easy access to the information for the investors, agents etc. and will make redressal process more transparent.

NSI set up coordination committees in all the states for redressal of Investors Grievances

The coordination committee have been set up in all the states for redressal of investors grievances and other issues concerning the agents' distribution channels, State Governments etc. The Coordination Committee is chaired by the Regional Director of the Regional Center of the concerned area with the representatives of the State Govt., Deptt. of Post, Banks and Agents. The coordination Committee will meet at least once in three months and atleast three meetings in each state will be conducted during the year 2006-07 by the RD's. The Regional Directors have fixed the specific days & hours in a week in each state for meeting the investors with a view to understanding and redressing their grievances. RD's will devote at least three days in a week at the Head Quarter of the Regional Center. The Regional Director giving cover to the state(s) which do not have a NSI Regional Center will visit the State Capital(s) at least once in every two months for a minimum of two days for meeting the investors and addressing their gueries and complaints.

Publicity about the fixed days on which RD's would be available to the Public is made through local media as well as notices in post offices and bank branches. The State Govts. are extending all out support in effective functioning of the coordination committee in their state. Besides investors grievances various issues like availability of NSI Products related forms, receipt books, services provided by the distribution channels etc. are discussed.
