Hon'ble Finance Minister, Government of West Bengal Reviews Progress of Small Savings Collections

Shri Anil Bhattacharya, Director & Head NSI, Government of India, Ministry of Finance during his visit to Kolkata in August 2007 called on Dr. Asim Dasgupta, Hon'ble Finance Minister, Government of West Bengal, Senior Officers of the Finance Department and discussed about the strategies to be adopted for achieving the Net target of Rs. 10,000/- cores fixed for the West Bengal state for the year 2007-08. Shri Anil Bhattacharya, apprised the Hon'ble Finance Minister that NSI has set an ambitious target of opening one lakh accounts within 6 months from August 2007 to December 2007 to sustain the market share of NSI. To achieve this NSI would be launching special savings campaigns and publicity through out the country with a focus on rural, farflung and hilly areas.

He further mentioned to the Hon'ble Finance Minister that NSI has been organizing Training Programmes in the state for the Small Savings Agents and the Officials of the Distribution Channels i.e. Department of Post and Banks to enable them to mobilize maximum savings and provide better customer services to the clients of NSI. He also mentioned that NSI is playing an active role in promoting International co-operation among the members of World Savings Banks Institute - Asia Specific Region. Shri Anil Bhattacharya also met Shri S.Sarkar, Chief Post Master General, West Bengal circle and discussed about various problems faced by the investors, agents at the distribution channel and he has assured to extend all co-operation.

Government of India Amends Post Office Monthly Income Scheme

In exercise of the powers conferred by Section 15 of the Government Savings Bank Act 1873 (5 of 1873) the Central Government has amended the Post Office (Monthly Income Account) Rules, 1987 vide their Notification No. GSR 521 (E) dated 1/8/2007 and these rules are now called as Post Office (Monthly Income Account) (Amendment) Rules 2007. These rules have come into force from the date of their publication in the Official Gazette.

Under the Amendment "A depositor may operate more than one account under these rules subject to the condition that the deposits in all accounts taken together shall not exceed Rs. 4.5 lakh in single account and Rs. 9 lakh in joint account under rule 4". The previous limit was Rs. 3 lakh in single account and Rs. 6 lakh in joint account respectively. Similarly under rule 5 (1) "There shall be only one deposit in Post Office Monthly Income Account in multiple of Rs. 1,500/- not exceeding Rs. 4.5 lakh in case of single account and Rs. 9 lakh in case of joint account".
