# Govt. of India Issues Clarification on opening of PPF Account by persons having dual citizenship

Many queries were received by the Ministry & this office whether a PPF account can be opend by an individual having dual citizenship. It has now been clarified by the Ministry of Finance (DEA) vide their letter No. F.7/12/2005-NS-II dated 31st January 2007 that the matter that PPF account can be opened by individuals having dual citizenship (one of India), but who is not an NRI, and such accounts shall continue to operate according to the extant rules till its maturity.

Further, so long as the person concerned holds the citizenship of India and is not an NRI, such accounts shall be eligible for extension or allowed to continue after expiry of the maturity period as per extant rules. Also the benefits accruing to the investor will be available only on a non-repatriation basis.
