Director NSI Reviews Small Savings Collections in the State of Tamil Nadu

Shri Anil Bhattacharya Director, National Savings Institute, Govt. of India during his visit to Chennai from 6-7 April 2007 met Shri L.K. Tripathi, Chief Secretary I.A.S., Govt. of Tamil Nadu and discussed about the strategies to be adopted for mobilization of resources for achieving the target fixed for the state for the year 2007-08. He also reviewed the progress of small savings in the state during the year 2006-07.

He informed that the special efforts may be made by the state in rural area since there is a tremendous potentiality available for mobilization of resources, which has not been tapped so far. He also stressed the need for appointment of new agents, training of agents as well as launching of sales promotion champaigns in the bigger establishments, as this would enable the state to mobilize more collections and achieve the target of Rs. 4000 crores fixed for the year 2007-08. He also met Shri T. Murthy, I.A.S., Commissioner, Small Savings, Govt. of Tamil Nadu and discussed about strategies for making National Savings Products popular for the Tamil Nadu State.
