Govt. of India Issues Clarification on MIS

Many queries were raised on application of deduction of 1% deposit on premature closure of account after expiry of three years. It has been clarified by the Ministry that one percent deduction on MIS deposit on premature closure of account after expiry of three years from the date of opening of account shall be made in respect of all the existing accounts as well as those accounts which are opened on or after the date of notification NO. GSR 59 (E) dated 10th February 2006.
