Importance of World Thrift Day and Achievements of NSI

The World Thrift Day was first celebrated at Milan, Italy in 1924 on 31st October. In India it was celebrated on 31st October till 1984 but after the death of the then Prime Minister Smt. Indira Gandhi on 31st October, the World Thrift day is being celebrated in the country every year on 30th October. The basic objective of world thrift day celebration is to create an awareness among the masses about the virtue of thrift and saving.

The savings products of the Ministry of Finance are structured in such a way that it caters the needs of different segments of the society and being Government of India product, it has highest safety and security which is the prime objective for any investor. The achievements of NSO (now NSI) during last more than 50 years have been encouraging. In 1948 it could mobilize Rs. 100 crores whereas in 2007-08 NSI could collect Rs. 1,26,750 crores. The State Govts. and the extension agencies involved in mobilisation of savings also play a significant role in mobilisation of savings in India. The State Govts. get 100% share of the net collections made in their State as a loan from Govt. of India on long term basis which is used by the State Government for the developmental plans.
